A positive anti-EJ result strongly indicates anti - synthetase syndrome, which involves interstitial lung disease (ILD), myositis, Raynaud's, mechanic's hands, and arthritis. The strong association with ILD means early evaluation with pulmonary function tests (PFTs) and imaging is critical to assess lung involvement. Laboratory tests cannot be exclusively relied upon to establish a diagnosis for myositis or related inflammatory disorders. Thus, this result should be interpreted in the appropriate clinical context.
