The probes for 1p/1q and 19q/19p were enumerated in 100 nuclei. The 1p to 1q ratio was 1.00. The 19q to 19p ratio was 1.00. A normal ratio is approximately 1.0. Any ratio <0.80 is consistent with deletion of the region of interest.
